# Purpose of Title XX Funds

- The U.S. Department of Health and Human Services allocates Title XX for use in funding a variety of Social Services
- States are fully responsible, within the limitations of the law, for determining the use of allocated Title XX Funds
- Funds must be used to meet one of 5 goals



# Five Goals of Title XX

1. To achieve or maintain economic self-support to prevent, reduce, or eliminate dependency
2. To achieve or maintain self-sufficiency, including reduction or prevention of dependency
3. To prevent or remedy neglect, abuse, or exploitation of children and adults unable to protect their own interests or preserving, rehabilitating, or reuniting families
4. To prevent or reduce inappropriate institutional care by providing for community-based care, home-based care, or other forms of less intensive care
5. To secure referral or admission for institutional care when other forms of care are not appropriate or providing services to individuals in institutions



# Uses of Title XX Funds in Cuyahoga County

Cuyahoga County uses Title XX Services for the Division of Senior and Adult Services and Division of Children and Family Services.

Services primarily include:

- Case Management Services
- Congregate Meals for seniors
- Home Health Aide Services for seniors
- Protective Services for children and adults
- Intervention services for children and adults
- Information and referral services for seniors
